- 2) This is a Annual Festival, wherein a crowd of atleast 12,000 to 15,000 people visit the place for participating in several programmes. On order to provide appropriate play area for children during the festival, the Department has a space of apprx. 600 sq. mtrs. (15 X 40 mtrs) for installation of playing equipments/ games i.e. giant wheel, toy train, etc. alongwith circulation space. Any interested agencies/ parties/ owner with such type of equipments including all safety measures to quote their bids for the area as mentioned above alongwith the details of installation to be undertaken during the period.
- 3) All the equipments being installed shall be of such type which has all the safety norms for children.

Terms & Conditions:

1. The successful bidder shall provide a Bank Guarantee of 10% of the quoted amount as security within two days of the issue of the work order.
