Bid box provided in the office for the purpose before the due date and time. The Technical Bid and EMD shall be opened on the same day in presence of the Bidders or their authorized representatives who may desire to attend. The Financial Bid shall be opened only of the qualified bidders on a prescribed date and time which shall be intimated separately.
